2. Only those Candidates have been enrolled in the said Course, who appeared for the Counselling held at Panchkula and completed their documents in terms of Signing of Surety Bond & Filling of IGNOU Form.
3. Candidature of all those Candidates, who did not appear for the Counselling, or completed their documents in terms of Signing of the Surety Bond & Filling of the IGNOU Forms, or who were not willing to join the said Course stands cancelled.

5. The IGNOU has extended the last date for admission in said Course by 31st August 2020; thereby classes are likely to be started from the month of September 2020 onwards. Final information regarding initiation of the classes will be communicated by IGNOU at your registered Mobile No.; given by you in the Application Form.
6. After successful completion of the said Course, Candidate will be appointed as Community Health Officer (CHO) at the Sub Centre level Health & Wellness Centre in the District for which she/he applied. As per GoI norms, maximum two attempts will be provided for successful completion of the said Course. If any Candidate fails in 1st attempt, then she/he will have to bear all expenditure for the 2nd attempt.
7. If any Candidate leave the said Course in between, or leave the job before 3 years, then she/he shall be liable to pay the Surety/Penal Amount as per the Surety Bond signed with NHM Haryana.
