

## Public Notice-12

### A. “Counselling of 22 Candidates from WAITING LIST for Subsequent Joining as Mid-Level Health Providers-cum-Community Health Officers (MLHPs-cum-CHOs) on 29/09/2022

**Refer to the Public Notice-8; Dated: 01/08/2022 issued by this office for Provisionally Selected 784 Candidates; inviting them to appear for Counseling & Subsequent Joining as MLHPs-cum-CHOs through followed-up Public Notices 9, 10 & 1; Dated on 5<sup>th</sup>, 6<sup>th</sup> Aug. and 5<sup>th</sup> Sept. 2022, respectively.**

1. During the earlier scheduled Counselling, out of 894 provisionally invited Candidates, 793 have attended their Counselling; out of which total 761 Candidates have joined their duty in respective Districts. Against Counselling held on 05/09/2022, total **14 Candidates remained absent, and till time 05 have not joined their duty, 02 Medically Unfit and 01 Resigned, for which multiple times opportunities were given. Thus, total 22 vacant seats are considered for Counselling and subsequent joining in different Districts. The List of 22 Candidates is given in Table-6** (Click on Table-6 for downloading the list of 22 invited Candidates from Waiting List for Counselling).
2. For the purpose of Counselling & Subsequent Joining, **all 22 Candidates as per Table-6 are required to read Public Notices 8 & 9 carefully for more instructions.** All candidates are required to bring (i) **Original Valid Identity Proof**, and (ii) **03 Copies of Public Notice-8 and Public Notice-12 alongwith 03 Sets of Declared Result in Table 1 & 2 under Public Notice-8, and Table-6 under Public Notice-12**, (uploaded on the NHM Haryana Website), as per the below given Venue & Schedule:

**Important Note: The entire selection process, and all other conditions/instructions shall also remained applicable as mentioned in Public Notice-8 for these 22 Candidates from Waiting List. Therefore, all 22 Candidates are required to go through the Public Notice-8 thoroughly & carefully for considering conditions & instructions for their own candidature.**

**B. Detailed Instructions for 22 Candidates from Waiting List regarding scheduled Counselling & Subsequent Joining:**

1. At the time of Counselling, all the provisionally Selected Candidates from Waiting List are required to sign their "Surety Bond" as mentioned in the advertisement, and "**NHM Service Contract through Offer Letter**" with respective Civil Surgeons. For this purpose, **all the invited Candidates are required to bring (i) Blank Non-Judicial Stamp Paper of Rs. 100/- for Surety Bond, and (ii) Blank Non-Judicial Stamp Paper of Rs. 10/- for NHM Service Contract for signing of the same with concerned Civil Surgeons during Counselling**. The Non-Judicial Stamp Papers for Surety Bond, and Service Contract are required to bring "**Blank**", as both will be printed by NHM SHQ during Counselling Session, itself.
2. Further, **all candidates are also required to bring (i) Original Valid Identity Proof, and (ii) 03 Copies of Public Notice-8 and Public Notice-12 alongwith 03 Sets of Declared Result in Table 1 & 2 under Public Notice-8, and Table-6 under Public Notice-12 of their District only**, (uploaded on NHM Website).
3. The selected Candidates are required to satisfactorily serve the NHM Haryana for atleast 3 years continuously in the same District for which she/he has applied / selected and, in case any candidate leave the service before three years after signing of the Surety Bond, she/he shall be liable to financial penalty as per the conditions mentioned in the Surety Bond.
4. It is reiterated that the joining of the selected Candidates, as per Table-6 shall be non-transferable & non-deputationable, and purely contractual & provisional, as their services may be dispensed with any time subject to not meeting the eligibility criteria as per credential considered on the basis of produced Certificates at the time of document verification.
5. ***The provisionally selected Candidates shall be entitled of monthly honorarium which will be subject to decision taken by Govt. of Haryana Health Department / NHM Haryana from time to time, and they shall be abide by the subsequent improvisations / updations / directions made by Govt. of Haryana, Health Department / NHM Haryana from time to time.***
6. The provisionally selected Candidates, who have already completed the Added Qualifications, (i.e. BPCCHN Course from IGNOU or State University/Institution, or MLHP Course Integrated in BSC Nursing Curriculum) will be given direct joining as MLHP-cum-CHO. Remaining Candidates, who have not completed their added qualifications, will be sent for 6 Months BPCCHN in forthcoming Academic Session of the IGNOU.
7. The MLHPs-cum-CHOs, who are already working with NHM Haryana and selected as per Table-6 are required to abide by the terms & conditions of Surety Bond in the following manner:
  - (i) *Those, who have completed their 3 years' service as MLHP-cum-CHO as on date of their relieving from existing District without any break (except maternity leaves or medical leaves), are required to produce "No Objection Certificate (NOC)" from the Civil Surgeon, where they are currently working.*
  - (ii) *Those, who have not completed their 3 years' service as MLHP-cum-CHO as on date of relieving from respective District, are required to deposit "Penalty Amount" as per the Terms & Conditions of their signed Surety Bond with the Civil Surgeon, where they are currently working. Further, they are also required to take NOC from the Civil Surgeon, where they are currently working for the purpose of their joining in new District.*
8. If any Candidate fails to attend the Counselling Session as per fixed schedule, her/his candidature shall be considered cancelled; even if he/she is the topper in the Waiting List of her/his category and no further opportunity will be given to any such candidate(s). **No other chance shall be given to any of the Candidate for Counselling & Subsequent Joining; if remained absent. Then candidature of the Absentee Candidates stands cancelled and their seats will be transferred to next Candidate in order of further merit in the Waiting List.** Further, the Competent Authority has the power to decide the matter on case to case basis.
