Public Notice-8

A. Declaration of Provisional Final Result of 787 Mid-Level Health Providers-cum-Community Health Officers (MLHPs-cum-CHOs) for Counselling & Subsequent Joining

Refer to the Advt. No. 1/2021-22(HWC-CP)/672; Dated: 20/03/2022, and in continuity of the Public Notice 1 to 7 issued by this office for the selection of 787 Mid-Level Health Providers-cum-Community Health Officers (MLHPs-cum-CHOs) to be engaged for the Sub Centre level Health & Wellness Centres (SC-HWCs) in 20 Districts of Haryana under Ayushman Bharat.

This is for information of all the Applicants, who appeared in the OMR Based Exam held on 24th April 2022 at Chandigarh, and Shortlisted Candidates in order of District & Category-wise Merit called for Document Verification held from 10th May to 02nd July 2022 at Panchkula, that the Final Result has been prepared adopting following process:

1. Merit has been considered on the basis of Essential Academic Qualification as mentioned by the Candidates in their Online Application Forms.
2. Candidature of following Candidates has been rejected on the basis of document verification:
 - (i) *Who are not possessing Essential Academic Qualification(s) on the last date for applying, as per the advertisement.*
 - (ii) *Who were "Absent during Document Verification despite special chance given to them".*
 - (iii) *Against whom, FIR have been lodged with police on account of producing Invalid/Fake Certificates during document verification to avail the benefit of additional 05 marks for added qualifications.*
3. Final Merit has been prepared considering the marks obtained in the OMR Based Exam, plus additional 05 marks for added qualifications (i.e. Integration of MLHP Course in the Curriculum of BSc Nursing as per the Notifications of Indian Nursing Council, or 6 months BPCCHN Course completed from IGNOU or State University/Institution as per Gol Guidelines), subject to validity of the said Certificate during the Document Verification.
4. In case of equal marks obtained in the overall merit (i.e. Written Exam plus additional 05 marks for added qualification) by two or more Candidates in particular Category, then merit has been decided on the basis of seniority in age, as mentioned in the advertisement.
5. The additional 05 marks for added qualifications (i.e. Integration of MLHP Course in the Curriculum of BSc Nursing as per the Notifications of Indian Nursing Council, or 6 months BPCCHN Course completed from IGNOU or State University/Institution as per Gol Guidelines: subject to validity of the said Certificate during the Document Verification) are considered as per the Legal Opinion sought from the O/o Ld. Advocate General Haryana, on the following basis for the purpose of preparing provisional final result, if the aforesaid added qualification is:
 - (i) *"Mentioned in the Online Application Form and the Valid Certificate is also Uploaded alongwith PDF by the Candidate";*
 - (ii) *"Mentioned in the Online Application Form but Valid Certificate is not uploaded alongwith PDF documents by the Candidates";*
 - (iii) *"Not mentioned in the Online Application Form but Valid Certificate is uploaded alongwith PDF documents by the Candidates".*

6. Additional 05 marks for the added qualifications are not considered in the merit of all those Candidates, who have "Wrongly filled their Online Application Form by way of not mentioning about their added qualifications, nor uploading the Valid Certificate alongwith PDF documents despite multiple times Instructions in the e-application itself and twice Undertaking to/of the Candidates at the time of filling their Online Application Form on the Portal" (i.e. Integration of MLHP Course in the curriculum of BSc Nursing, or 6 month BPCCHN Course from IGNOU or State University/ Institution). The non-consideration of Additional 05 Marks for not mentioning of Added Qualifications by such Candidates has also got legally opined by O/o Ld. Advocate General (Haryana).
7. Rules under Reservation Policy issued by the Haryana Government from time to time, have been adopted for providing reservation benefits to the candidates belonging to reserved categories.
8. Candidatures of all those reserved category Candidates, has been considered under General or respective Main Category in order of their merit, who have not produced their requisite Certificate of Caste/Category/Income & Asset/Eligibility etc. alongwith the Haryana Domicile/Resident Certificate.
9. The Candidates, who are already working as MLHPs-cum-CHOs, and if selected for another District, they shall have to fulfill the conditions of Surety Bond and all such Candidates are required to submit NOC (even if, 3 years Surety Bond period is completed) from the Civil Surgeon concerned; where they are working currently. Penalty amount for Surety Bond shall not be waived-off for any of such Candidate for fresh joining against the current selection. These Candidates are required to attend their Counselling as per Schedule to submit their undertaking.
10. Considering the points mentioned at Sr. No. 1 to 10, the District & Category-wise Provisional Result has been prepared on the basis of physical verifications of the documents conducted in three round at NHM SHQ. In compliance with Order Dated: 23/05/2022 passed by the Hon'ble High Court for Punjab & Haryana (Chandigarh) under CWP No. 11098 of 2022, final result has been prepared in accordance with the merit list qua each category, and same has been placed on the NHM Website for information of all Candidates; wherein marks obtained by each Candidate are shown clearly & transparently in their respective Category & District applied for.
11. Provisional Result has been prepared in order of District & Category-wise Merit as given in the **Table-1** for information of all concerned ([Click here for Table-1](#)). **Candidates are required to click at "Table-1" to download Result.** Detailed instructions in above references are given ahead for attending Counselling & Subsequent Joining and no separate communication will be sent to any of the candidates for this purpose.
12. The brief Summary of the Provisional Result considered for Declaration is given below:

**Although shifted in General Category, but their merit is very low due to which their candidature has not been considered for the result, as Candidates in General Category with higher merit as compared to them were not shortlisted for documents verification.*

13. The candidature of all such Candidates, who have been given additional 05 Marks on the basis of their added qualifications, (as mentioned under Sr. No. 5) and Candidates, who have been benefited under reserved categories (as mentioned at Sr. No. 7-8) on the basis of their produced supporting documents, may be rejected at any time (even after formal joining), if their Certificate/Document(s) is/are found invalid/fake at any stage and Legal Action may also be initiated against such candidates in future.

B. Detailed Instructions for Selected Candidates regarding Counselling and Subsequent Joining:

1. Only the provisionally “Selected Candidates” in their respective Categories as mentioned in **Table-2**, ([Click here for Table-2](#)). **Candidates are required to click at “Table-2” to download List of Selected Candidates** are required to attend the Counselling for Subsequent Joining, as per the Schedule & Venue given ahead.
2. For the purpose of Counselling & Subsequent Joining, all the provisionally Selected Candidates are required to bring (i) Original Valid Photo Identity Proof (like: Official Identity Card, ADHAAR Card, Voter Card, Passport, Driving License etc.), and (ii) 03 Copies of Public Notice-8 alongwith 03 Sets of Table-1 and Table -2 (uploaded on the NHM Haryana Website) highlighting their Roll No. in both the lists, as per the below given Venue & Schedule:

***No other chance will be given to any of the candidates for counselling other than dates mentioned above**

3. At the time of Counselling, all the provisionally Selected Candidates are required to sign their “Surety Bond” as mentioned in the advertisement, and “NHM Service Contract through Offer Letter” with respective Civil Surgeons. For this purpose, all the selected Candidates are required to bring (i) Blank Judicial Stamp Paper of Rs. 100/- for Surety Bond, and (ii) Blank Judicial Stamp Paper of Rs. 10/- for NHM Service Contract for signing of the same with concerned Civil Surgeon. The Judicial Stamp Papers for Surety Bond, and Service Contract are required to bring “Blank”, as both will be printed by NHM SHQ during Counselling Session, itself.
4. The “Candidates in Waiting as per Table-1” are not required to attend the scheduled Counselling; as the Candidates in Waiting to be called individually, if any position remained vacant in respective District/Category.
5. The provisionally selected Candidates (as per Table-2), who were not able to produce their Registration Certificates with respective Council at the time of Document Verification, are required to submit their Registration Certificate within 2 months, positively after their joining with respective Civil Surgeon. If she/he fails to submit the required Registration Certificate within stipulated period, administrative action will be initiated/taken against such Candidates by the Competent Authority on case to case basis, which may amounts to termination of his/her Service Contract.

6. If any Candidate fails to attend the Counselling Session as per fixed schedule, her/his candidature will be considered cancelled, even if he/she is the topper in her/his category for the said post and no further opportunity will be given to any such candidate(s). Further, the Competent Authority has the power to decide the matter on case to case basis or unitedly as a whole.
7. The selected Candidates are required to satisfactorily serve the NHM Haryana for atleast 3 years continuously in the same District for which she/he has applied / selected and, in case any candidate leave the service before three years, she/he shall be liable to financial penalty as per the Surety Bond conditions.
8. It is reiterated that the joining of the selected Candidates, as per Table-2 shall be non-transferable & non-deputationable, and purely contractual & provisional, as their services may be dispensed with any time subject to not meeting the eligibility criteria as per credential considered on the basis of produced Certificates at the time of document verification. However, place of positing shall be bound by the guidelines of Govt. of Haryana, Health Department / NHM Haryana from time to time.
9. The provisionally selected Candidates, who have already completed the Added Qualifications, (i.e. BPCCHN Course from IGNOU or State University/Institution, or MLHP Course Integrated in BSc Nursing Curriculum) will be given direct joining as MLHP-cum-CHO. Remaining Candidates, who have not completed their added qualifications, will be sent for 6 Months BPCCHN in forthcoming Academic Session of the IGNOU.
10. The MLHPs-cum-CHOs, who are already working with NHM Haryana and selected as per Table-2 are required to abide by the terms & conditions of Surety Bond in the following manner:
 - (i) *Those, who have completed their 3 years' service as MLHP-cum-CHO as on date of their relieving from existing District without any break (except maternity leaves or medical leaves), are required to produce "No Objection Certificate (NOC)" from the Civil Surgeon, where they are currently working.*
 - (ii) *Those, who have not completed their 3 years' service as MLHP-cum-CHO as on date of relieving from respective District, are required to deposit "Penalty Amount" as per the Terms & Conditions of their signed Surety Bond with the Civil Surgeon, where they are currently working. Further, they are also required to take NOC from the Civil Surgeon, where they are currently working for the purpose of their joining in new District.*
11. The provisionally selected Candidates shall be entitled of monthly honorarium which will be subject to decision taken by Govt. of Haryana Health Department / NHM Haryana from time to time, and they shall be abide by the subsequent improvisations / updations / directions made by Govt. of Haryana, Health Department / NHM Haryana from time to time.
12. It is reiterated that the candidature of all such Candidates, who have been given additional 05 Marks on the basis of their added qualifications, (as mentioned under Sr. No. A-5) and Candidates, who have been benefited under reserved categories (as mentioned at Sr. No. A7 & A8) on the basis of their produced supporting Certificates, may be rejected at any time (even after formal joining), if their Certificate(s) is/are found invalid/ fake at any stage, and Legal Action may also be initiated against such candidates in future.
13. Final joining of each Candidates is subject to their Medical Fitness Certificate issued by concerned Civil Surgeon of respective district, as per Haryana Govt. Norms.
14. No separate communication will be sent to any of the selected Candidate regarding Counselling & subsequent joining, therefore, all provisionally selected Candidates are required to attend the Counselling as per schedule only. No Candidate will be entertained for Counselling & subsequent joining away from the fixed schedule.
15. No TA/DA will be given to Candidates for appearing in Counselling and subsequent.
16. All communication will be issued only through NHM Haryana Official Website (i.e. www.nhmharyana.gov.in). Therefore, all Candidates are suggested to keep checking the NHM Website for latest updates.
17. The Competent Authority can take any decision regarding the Counselling, Joining and Post-joining etc. pertaining to this Public Notice, in view of peculiar and compelling circumstances.
